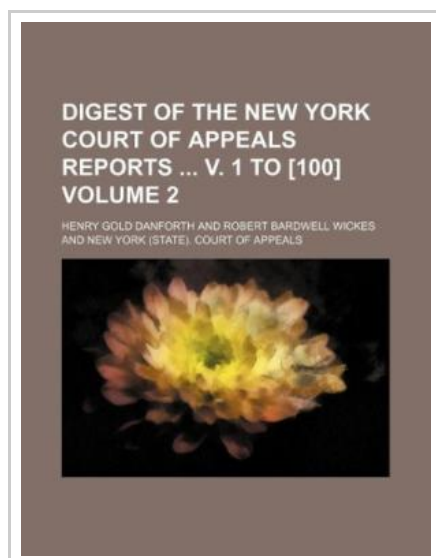

Contract between receiver of insolvent Xew York company and Connecticut company, by which latter agreed to assume liability of former company on outstanding policies, construed and held that latter, by surrender of said policies, became a policy-holder in former, and was not entitled to share in fund deposited with insurance department. Reese v. Smyth, 95 X. Y. 645. An insurance company transferred bond and mortgage to a trust company, as security for its policy-holders, reserving right to receive the interest, and later made general assignment. Held, in absence of proof that there were no policy-holders to be protected, the foreclosure producing less than the interest due, the trust company was entitled to proceeds of the sale. Fullerton v.
